Parade Date: Saturday, April 22, 2017 at 10:30 am

Entrance Fee: Waived

1. **GENERAL:** Parade Application and Waiver Forms must be completed and mailed to the address shown by April 7, 2017.
2. All participants under the age of twelve (12) must be accompanied by a parent, guardian, or responsible adult in addition to the driver.
3. All participants under the age of six (6) must sit in the car and may not sit on the hood, trunk, or sunroof of the vehicle.
4. Signs identifying the name of the pageant and the winner must be displayed on the right and left sides of the vehicle or boat. Professionally designed magnetic signs are recommended.
5. Miss Grifton contestants, runners up and the 2017 Miss Grifton (boats) will line up by 9:15 am in the circular driveway in front of Grifton School on Church Street with Miss Grifton being last in line. Enter the driveway closet to Dawson Street so you will be facing the school parking lot (South).
6. Other pageant winners will line up by 9:15 am on Dawson Street as directed by parade officials.

ROUTE:

1. Participants will line up as described above by 9:15 am on Saturday, April 22, 2017
2. Participants will be merged into the parade line-up from Dawson Street and the circular driveway as directed by parade officials. The Parade will turn left (SOUTH) on Church Street, turn right (WEST) on McCrae Street, turn left on DuPont Street (SOUTH), and turn left on Queen Street (EAST) with the parade ending at Grifton School.
3. The Parade Officials receive the right to deny entrance to the parade for:
 - a. Late Arrivals.
 - b. Entries that do not comply with the guidelines.
 - c. Entries deemed inappropriate or unsafe.
