Entry Guidelines

Parade Date: Saturday, April 22, 2017 at 10:30 am Entrance Fee: Waived

- 1. GENERAL: Parade Application and Waiver Forms must be completed and mailed to the address shown by April 7, 2017.
- 2. CLOWNS: Names of all CLOWNS must be included on the application as participants.
- 3. CARS: All car doors must remain closed while in movement.
- 4. All HORSES must be groomed for show and riders must be in appropriate dress. A parent, guardian, or responsible adult must accompany any rider under the age of 16. All equestrian individuals or groups are responsible for providing their own "pooper scooper."
- 5. CARS, GOLF CARTS, MOTORCYCLES, and FLOATS: All must have a sign or banner on each side to identify your group or business.
- 6. FLOATS: Tractors can be used to pull floats but cannot be floats. Pick-up trucks can also be used to pull a float or it can be a float if it is appropriately decorated. Trophies will be awarded to the float best representing this year's theme, "Good Vibrations." Floats will be judged as they pass the reviewing stand on Queen Street. Trophies will be awarded within 10 minutes after the parade is finished.

ROUTE:

- 1. You shall line up by 9:15 am, heading WEST on Dawson Street as directed by parade officials.
- 2. Participants will be merged into the parade line-up from Dawson Street. The Parade will turn left (SOUTH) on Church Street, turn right (WEST) on McCrae Street, turn left on DuPont Street (SOUTH), and turn left on Queen Street (EAST) with the parade ending at the car wash by Grifton School. All participants on foot can return to the front entrance of Grifton School and all others return to Dawson Street by turning left (NORTH) on Wall Street.
- 3. The Parade Officials receive the right to deny entrance to the parade for:
 - a. Late Arrivals.
 - b. Entries that do not comply with the guidelines.
 - c. Entries deemed inappropriate or unsafe.
